Sub: Report of the scientific deliberation on "Preparedness for Competency Based Education" on August 24th, 2022, organised by HPEU - DAPM RV Dental College

Respected Madam,

The scientific deliberation on "Preparedness for Competency Based Education" on August 24th, 2022, organised by HPEU, DAPM RV Dental College, Bangalore was successful in initiating a conversation regarding the competency based education and role of the educational leaders. Seventy five participants (internal and external) were part of the audience. Our key note speaker and panellists led by Dr. Avinash Supe, Dr. Suhasini Nagda, Dr. Pushpanjali and Dr. Anshu deliberated on the need for competency based education, and change management strategies for stakeholders – regulatory bodies, Management, faculty and students.

The key take home messages were:

1. Educational leaders need to initiate change and not necessarily wait for the regulatory bodies to make policy decisions.
2. Competency based education is here to stay – it is student centred and addresses the needs of the community. The faculty will have to modify their teaching styles to support this shift in education.
3. Competency based education strategies are aligned to the National Education Policy 2020, NAAC and NIRF requirements.
