**REPORT ON INFECTION CONTROL AND WASTE MANAGEMENT PROTOCOL**

Department of Oral Medicine and Radiology follows the following steps for infection control

**Oral Medicine Section:**

1. Dental chairs and seating areas are disinfected with 2% glutaraldehyde every morning.
2. The patients are asked to rinse their mouth with Chlorhexidine mouth wash before the start of examination. After every patient examination the dental chair is disinfected
3. Dental instruments after usage are soaked in soap solution for minimum of 30 min then scrubbed with soap and washed under running water then instruments are soaked in glutaraldehyde solution and kept for 45 minutes. Further they are dried and sealed in sterilization pouches and then autoclaved for 20 min.

**Radiology Section :**

1. Radiology equipments are disinfected with 2% glutaraldehyde every morning.
2. After every intraoral radiographic examination procedure the IOPA film is washed in running water and then the film is placed in 2% glutaraldehyde solution and further it is subjected for processing.
3. Before every Panoramic and CBCT radiographic procedure, the bite block is wrapped with cling wrap and is disposed off after the radiographic examination. All the contact areas are disinfected with glutaraldehyde before each patient.

The clinical area both Medicine and Radiology areas are fumigated at the end of the clinical hours each day by super oxidized water (hypochlorous-Eko power HOCL)

**Infection Control and Waste Management Protocol**

The department of Public health Dentistry follows all the standard infection control and Waste management protocol as mandated by the Hospital Infection Control Committee (HICC) of the institution. The III year, IV Year, Interns and PGs are briefed about the basic protocols to be followed for infection control before each posting & periodically.

1. The dental chairs are wiped after each patient with a suitable disinfectant.
2. Disposable patient drapes are used. In case of reusable drapes, each drape is cleaned with a suitable disinfectant after every use.
3. SOPs for covid are being followed as mandated by the HICC of the institution.
4. Aerosol procedures are done in separate cubicles, with sufficient ventilation with exhaust fans.
5. Following all aerosol procedures, sodium hypochlorite is sprayed on the dental chair and entire working field.
6. The instruments required for a particular procedure are washed & scrubbed clean and then sealed in sterile pouches and then autoclaved before use.
7. Periodic swabs are taken from clinical areas to check & verify infection control protocols being followed.
8. Printouts of hand washing techniques are displayed at the washing areas in the department. Waste segregation is followed according to the instructions provided by the HICC of the institution.
9. The group D staff are also informed about the waste segregation process to be followed.
10. Infection control register is maintained and updated on a daily basis.
11. The instruments required for every camp are washed & scrubbed clean and then sealed in sterile pouches and then autoclaved before taking for the camp.





**IV. Report on Infection control & waste management protocols followed in their respective departments.**

**Copies of sterilization register**

- Immunisation: Department makes sure that all the PG and UG students have current immunizations against communicable diseases like hepatitis B.
- Instrument Sterilization: Cleaning, packing and sterilization of all diagnostic instruments and orthodontic pliers are carried out as a regular sterilization protocol. Non- Sterilizable instruments are disinfected using chemical disinfectants.
- Surface Asepsis: Cleaning and Disinfection of the contaminated surfaces using surface disinfectants like sodium hypochlorite is carried out every day and after every patient the dental chair unit and operatory area is disinfected.
- Personal Protective wear like head cap, mouth mask, gloves are worn at all the times while treating patients. Face shield and protective outer garments are worn for aerosol producing treatment procedures and always changed between patients
- Waste management: Disposal of dental waste in appropriate coloured bins is practiced by the department PG and UG students. Group D staff are trained about proper waste segregation procedures by the infection control committee.
- Blood Spillage kit is maintained in the department
- Sterilization register is maintained and updated on daily basis
- Periodic swabs are taken from clinical areas to check & verify infection if control protocols are being followed and report for the same is maintained.
- Handwashing technique and waste disposal charts are displayed in department.

**Infection Control & Waste Management Protocols 2022-2023**

The Dept of Prosthodontics follows all the standard infection control protocols. The III year, IV year, Interns & PGs are briefed about the basic protocols to be followed for infection control before each posting & periodically.

- The dental chairs are wiped down after each patient with a suitable disinfectant.
- Disposal patient drapes are used
- Aerosol procedures are done in separate cubicles, with sufficient ventilation with exhaust fans.
- The instruments required for a particular procedure are washed & scrubbed clean and then sealed in Sterile pouches and then autoclaved before use.
- A blood spillage kit is maintained.
- Periodic swabs are taken from clinical areas to check & verify infection control protocols being followed.
- Impressions are disinfected with a suitable disinfectant agent.
- Appropriate lab disinfection procedures are followed.
- PPE are worn when performing implant surgical procedures
- The technicians are also briefed about the infections control procedures to be followed.
- Printouts of hand washing technique are displayed in the department.
- Waste segregation is followed according to the instructions provided by the infection control committee of the institution.
- The group D staff are also informed about the waste segregation procedures to be followed.
- Infection control register is maintained and updated on a daily basis.
- Hepatitis B vaccination programs are conducted by the infection control committee of the institution and all faculty, students, technicians and group D staff are vaccinated
- Annual infection control workshops are conducted for the III BDS and I MDS students (prior to entry to clinics)
